# 182/15 APOLOGIES OF ABSENCE

Apologies were received from Councillors N James, K Roberts and S Slater, for whom it was resolved to grant approval of absence.

# 183/15 DECLARATIONS OF INTERESTS

There were no Declarations of Interests.

# 184/15 PUBLIC PARTICIPATION

There was no Public Participation

#### 188/15 FINANCIAL SUPPORT FOR FLOOD RELIEF

Following the previous approval of a £500 donation for business reparation it was resolved this payment now be made to Community Foundation for Calderdale, specifying the business element. (This brings the total grants for flood relief to £1,000)

# 189/15 RISK ASSESSMENT

Councillor Edwards reported that he had nothing adverse to report at present but, in view of current weather conditions, he would undertake a further inspection of The Pinfold in a few days time and would make a further report if considered appropriate.

#### 190/15 2016/17 FINANCE : ESTABLISHING THE PRECEPT

The recommendations from the council's Finance Committee were considered and as a result the following decisions were resolved :

- Clerk's salary be increased by 1% from 1 April 2016 in accordance with NJC national recommendations.
- 2. **Chairman's Allowance** be increased by a compounded 1% from the April 2014 figure.
- 3. Grants be approved as follows:
  - Royal British Legion wreath + donation = £100
  - Heptonstall Social & Bowling Club: Parking Provision of £250 + £800 for electrical work. It was resolved to consider a supplementary claim at the meeting to be held 7 March, to which the Treasurer be invited to attend.
  - Heptonstall Bowling Club: green maintenance equipment £900.
  - Heptonstall Communications Group : £800 for Newsletter publication
  - Heptonstall Lights & Planting Group: £200 for Xmas tree insurance
  - Pennine Spring Music: £250 for sponsorship of youth activity
  - Richard Naylor Charities & Heptonstall Exhibitions: set at 2 x £500 to one side to be released when a presentation and financial information is considered on 7 March 2016.
  - Heptonstall Festival Committee £250
  - Contingency Provision £2.000
- 4. **Precept** for 2016/17 be £16,540 (in addition to grants of £952 & £1,383 = £18,875)
- 5. **Insurance** cover was approved for renewal from 1 June 2016.
- 6. **Investment Strategy** to be continued using Term Deposits renewable on a six month basis.
